n the afternoon of Tuesday, 9 Adar II 5733 (March 13, 1973), Mushka Raskin, a 13year-old student at Beis Rivkah High School, located at the time at Snyder and Bedford Avenues, in Brooklyn, was crossing the street outside the school and was struck by a speeding van. She was taken to Kings County Hospital in a coma. Upon receiving the news, her father, the legendary chossid, Rabbi Dovid Raskin, of blessed memory, wrote a heartfelt *pan* to the Rebbe, 'giving her over' to him. The Rebbe, in response, instructed Dr. Robert Richter to visit her daily and report back to him personally afterwards. A month later, she returned home.

The following are first-hand accounts of this near fatal accident and resulting open miracle.

## The Tragedy

#### Mushka's Classmates

We had just returned from a class trip to the United Nations. At approximately 4:00 PM, as we were leaving school and heading to the bus stop for home,

Mushka noticed a teacher of ours, with whom she was close and who had been out of school for some time, and attempted to cross Bedford Avenue to greet her. A speeding van then drove through a red light, struck her, and fled the scene. Mushka was thrown several feet into the air before landing hard on the pavement, leaving her unconscious. Nearby was a fire station, and a fire truck arrived and rushed her to Kings County Hospital.

## The Rebbe Instructs

R. Dovid came into the secretariat and told me that his daughter was struck by a vehicle near Beis Rivkah and that she was in critical condition at Kings County Hospital. I told him to immediately write to the Rebbe.

He wrote in his *tzetel* [note]:

"I hereby consign, my daughter, Chaya Mushka bas Chava Elka, to the Rebbe, *shlita*; from now on, she is the Rebbe's daughter."

"You should contact Dr. [Robert] Richter [a surgeon who shared a close relationship with the Rebbe], and I would like to see him as soon as possible."

I called Dr. Richter, and his secretary told me that he was in the middle of performing an operation. I told her to please tell him that Rabbi Groner called and it's urgent. A bit later he called me back, and I told him that the Rebbe must see him as soon as possible.

He worked nearby, at Brooklyn Jewish Hospital, so a short while later he arrived at '770' and went straight into the Rebbe's room.

When he came out, he told me that the Rebbe told him that he wanted him to visit her daily and report back to him about her condition. He told the Rebbe that he's not a member at Kings County Hospital. To which the Rebbe answered (paraphrasing), "What difference does it make if you're a member or not, according to them, it's practically over." The following

night he came back to '770', and when I saw him, I was ready to go in to the Rebbe to inform him that he had arrived, but he insisted that he would speak with the Rebbe when the Rebbe was ready to go home. When the time came, the Rebbe opened the door, and he went in. He came out around ten or fifteen minutes later and told me that he informed the Rebbe of her condition, and the Rebbe thanked him.

When he came back on that Thursday night, he told me, upon leaving the Rebbe's room, that he could not believe what the Rebbe had just told him: "Tomorrow night, Shabbos, after you finish the Shabbos meal with your family.

visit the hospital, and then come here to report." The doctor, who was *shomer shabbos*, said to me, "Do you understand what the Rebbe is telling me?!"

This would continue for around a month; each evening he would come into the Rebbe and report on her condition. Around two weeks after the accident, Dr. Richter reported that her condition was improving. Four weeks later, I received a call at the office from a doctor at Kings County Hospital. He introduced himself as the first neurologist who had treated her, and he told me, "I am not Jewish, but I have to tell you, Rabbi Schneerson performed an open miracle here! Medically, we had nothing else we could've done for her. In about a week or

two, she'll be able to stand, and a week later this young lady will be able to walk out of this hospital on her own two feet!"

## R. Dovid's Panim

The day following the tragic accident, R. Dovid penned the following heartfelt *pan* to the Rebbe:

#### B"H. 10 Adar II, 5733

Regarding my daughter, Chaya Mushka bas Chava Elka, I informed the secretariat several times about her condition. She is still in need of abundant mercy. The doctors say that her condition is now in the hands of G-d, Who heals the sick. I request the Rebbe's bracha for her that she be healthy in all aspects, soon, indeed...

Several days after the accident, and shortly before her 14th birthday, R. Dovid wrote to the Rebbe:

Please arouse abundant mercy for my precious daughter, Chaya Mushka bas Chava Elka, may she be well. On 16 Adar II, she will be turning fourteen years old, may she live long and healthy years. May G-d

Almighty send her a full and speedy recovery, in the form of visible and revealed goodness, down in this world.

## **Hospital Visits**

R. Shimshon Stock, a"h, was a chossid and activist who was known to all for his exceptional

kindness in the Crown Heights community and a longtime friend of Mushka's father, R. Dovid. He would visit Mushka daily, often spending many hours at the hospital. He would drive her classmates to the hospital regularly and had them make noise in the hope that she would wake up. One classmate vividly recalls Shimshon shaking Mushka's bed, pleading that she wake up...

His son, Benzion, and daughter, Chani, who was also a classmate of Mushka, relate: The doctors who were treating her told R. Dovid that her chances of survival were slim and even asked him to consider donating her organs, particularly the kidneys and eyes, to medical research.

## **Strength in Trying Times**

*R. Shlomo Zarchi, Mashpia at Central Lubavitch Yeshiva - 770 and a relative of the Raskin family* 

My wife and I would visit her in the hospital daily. Even in the most pressing and challenging of times, R. Dovid didn't lose himself.

I remember once during a visit at the hospital, her condition took a turn for the worse, and the doctors told R. Dovid that they didn't see a chance for a recovery, and it was only a short time until G-d forbid...

It was unbelievable how, at that desperate moment, R. Dovid kept his composure, picked

up the phone, and called the mazkirus to request a brocha from the Rebbe.

During a Shabbos farbrengen while she was still in a critical condition, R. Dovid approached the Rebbe for a brocha for Mushka. The Rebbe responded that he shouldn't ask a brocha for her until she returns home.

On Purim, several days following the accident, while she was still in a coma, R. Shimshon Stock, had an idea to arrange a minyan of chassidim give the

Rebbe a *pan* requesting a brocha for R. Dovid's daughter. He decided that three kohanim,

Shimshon himself, R. Zelig Katzman, and I, would present the Rebbe with the *pan* while the rest of the minyan would stand nearby.

We stood by *Gan Eden Hatachton* [antechamber to the Rebbe's office] waiting for the Rebbe to come out for mincha. The Rebbe left his room and went to the shul without mentioning anything. Following mincha, we were still positioned there; the Rebbe then asked Rabbi Groner, "Why are they standing here?" He answered, "they're here to request a brocha for R. Dovid's daughter." We then presented the Rebbe with the *pan*. After reading the *pan* (see copy below), the Rebbe responded:

"It should be fulfilled that 'G-d will grant your heart's desire for good' (see Tehillim 20:6, 37:4) and 'to anyone who extends a hand, one should give"" (Shulchan Aruch, Orach Chaim 694:3 (with regard to the mitzva of matanos l'evyonim on Purim)). 'problems'?' You have a Rebbe; there are no problems!' It was quite a sight to behold as he continuously repeated this. Everyone present understood quite well that he was essentially demanding this from himself... This left a strong impact on all those present, and on me personally, until this day."

## Improvements

Several days after Purim, Mushka's condition began taking a turn for the positive.

In the letter below from 21 Adar II, R. Dovid reports to the Rebbe about her improvement and the doctors' optimism for a recovery.

[Sunday,] 21 Adar II, 5733

Concerning my daughter Chaya Mushka bas Chava Elka's condition, she is still in need of tremendous mercy for a full and speedy recovery. I request the Rebbe's brocha for her.

Since Erev Shabbos, the doctors have seen no change, and Dr. Richter said so, as well. When my wife, Chava, and I visited her today, the doctors told me that she had opened her eyes slightly and attempted to lean forward as if to get up. They want to perform a spinal tap procedure on her, and were required to obtain parental consent beforehand. I told them [however] that I expect her to arise, and, furthermore, I would consult other doctors. א'] כ״א אדר שני תשל״ג[א']

Last Tuesday [16 Adar II – Mushka's 14<sup>th</sup> Birthday], when there was a major change for the good as she opened her eyes, all of the doctors said that she would soon recuperate, meaning naturally, too, there ought to be a quick recovery. I ask the Rebbe's brocha that very soon she should totally recuperate without any procedures, or the like, being necessary. May G-d send her a full and speedily recovery in all aspects, and may I be able to report good news, amidst joy and gladness of heart and true abundance.

## The Doctor's Perspective

Dr. Robert Richter, MD General Surgeon and former Associate Director of Surgery at Brooklyn Jewish Hospital

I was working at Brooklyn Jewish Hospital at the time when I received a phone call from Rabbi Groner. He told me that the Rebbe wanted to see me urgently. When I arrived, I went straight into the Rebbe's room. The Rebbe told me that Rabbi Dovid Raskin's daughter, Mushka, was hit by a vehicle and she was taken unconscious to the neurosurgical ICU at Kings County Hospital. The Rebbe asked me to go and see her, call her name and see if she responded, and then afterwards I should report back to him with as many details I could give.

I went to the hospital for about a half hour and spoke to the residents who were caring for

her. They informed me that she was brain dead and they had little hope of recovery. (Based on the criteria we had at the time, they assumed she was brain dead. She was areflexic [no reflexes, which is a sign of severe brain decerebrate injurv]. [abnormal posture that is indicative of severe brain injury], and EEG [device that records electrical function of the brain] was flat lined [also indicating severe brain injury]).

I came back the following night [Wednesday evening] and reported this to the Rebbe. The Rebbe told me then, without any hesitation, that he wants me to visit her daily and report back to him personally - no matter what time. I asked if Shabbos was included, and he said yes. (On Friday nights when I would pull up at 770, I had to keep my engine running and would ask a yeshiva bochur to watch my car in the meantime...).

That meant to me that, if the Rebbe was having me do something that involved *sakanah* [a life-threating matter], I was not simply acting as an informant for the Rebbe, but was acting as an agent for something directly related to her health. So I visited her daily (Shabbat and Sundays included), and I would go to her bedside and call out "Chaya Mushka," but there were no changes and she remained unconscious. I would report to the Rebbe daily, and he would tell me to continue what I was doing and call her name. This continued for approximately three weeks.

When I would update Rabbi Raskin on her condition, I never sensed any anxiety; it was as if he was expecting a complete recovery.

One day, when I called her name, she opened her eyes. She did not talk; she just looked at me. I got the goosebumps.

I reported this to the Rebbe, and he told me that it would not be necessary to continue the daily visits. I then asked the Rebbe if he knew all along that she would recover. He made a twinkle with his eye, as if to say he surely did...

I personally did not think she would survive, and, if she would, she would not function normally. I have seen many traumatic brain injuries throughout my career, including fatal ones, and the injury to Mushka should've been fatal. This was a pure miracle of the Rebbe, and I had the great fortune to act as his *shliach*.

I did not see her until her wedding [in 1981].

## Faith and Full Recovery

On 28 Adar II, while Mushka was recovering in the hospital, R. Dovid, his wife Chava, and their son Yitzchok had a yechidus with the Rebbe on the occasion of Yitzchok's Bar Mitzvah which would take place a week later on 7 Nissan. Chava requested a brocha for a full recovery for Mushka, and the Rebbe responded:

# "א recovery and full recovery and she א רפואה קרובה און רפואה שלימה און will be [home] at the seder for Pesach." (א רפואל זי זיין צום סדר."

(R. Dovid then asked the Rebbe's advice regarding a medical question. The Rebbe responded to ask Dr. [Avrohom Abba] Seligson, Dr. Richter, and repeated Dr. Seligson.)

On Motzei Shabbos, 5 Nissan, 5733, Yosef Y. Borovisk, an Israeli student at '770' at the time, wrote to his parents:

"...Something extraordinary occurred here recently: a daughter of R. Dovid Raskin was involved in a terrible car accident and has been unconscious for three weeks. A minyan of chassidim presented the Rebbe with a *pan*, therein requesting that she have full and speedy recovery, and the Rebbe responded that there should be good news. On the Thursday after Purim, we heard that she had started to speak. Then, on a recent visit to her in the hospital, when R. Dovid recited the Modeh Ani prayer, she repeated it after him... (If this isn't yet known in Israel, don't publicize it.)."

The following is part of a transcript (translated from Yiddish) from the recording of R. Dovid's speech at his son Yitzchok's Bar Mitzvah where he concludes by expressing his unwavering belief and best wishes for Mushka's recovery – 7 Nissan, 5733:

May G-d help that the chosson Bar-Mitzvah, his friends, and his family all be healthy, as the Rebbe has blessed. The Rebbe once said at a farbrengen, "When chassidim gather at a time of joy, there is a great joy Above." Since we recently experienced some painful incidents, there is no doubt that through the participation of everyone in our celebration,

will surely ease the pain, and the brochos of the Rebbe will surely bring an end to this [catastrophe].

May G-d help that we all should never hear of any hardships, and when something affects a family – and since all chassidim are one family – everyone will surely rejoice to eradicate any trace of sorrow.

May G-d help that very soon we merit to the coming of Moshiach, as the Rebbe often quotes [from the Gemara], "In Nissan they were redeemed [from Egypt] and in Nissan they will be redeemed [from their final exile]," may it indeed be very soon.

Following the Bar Mitzva, R. Dovid wrote a detailed report to the Rebbe about the simcha, concluding:

"My daughter Chaya Mushka bas Chava Elka, thank G-d, is steadily improving; still, however, she requires a feeding tube. The doctors are training her to eat normally. May Hashem help that she have a full and speedy recovery, leaving no trace, and there be no obstacle to her being home for Pesach in proper health..."

The Rebbe responded:

Thanks for the good news; I will mention it at the Ohel.


## In Her Merit

R. Tzvi Hirsh ("Heske") Gansburg, *a*"*h*, was a dear friend of R. Dovid and worked in a printing house, publishing many volumes of Chassidus. He also served on the executive board of Lubavitch Youth Organization (Tzach), which R. Dovid chaired. His children recall him going reguarly with R. Shimshon Stock to visit the hospital.

In merit for a full and speedily recovery for Mushka, he dedicated the Kehot 5733 new edition of the Haggada for Pesach with the Rebbe's commentary, which would include, for the first time, the Rebbe's *michtovim klolim* which he sent out for Pesach and his edited sichos on the Haggada.

## Home at Last

Besides for a scar on her lower right leg from the hit of the vehicle, Mushka did not sustain any permanent damage from the accident. Indeed, as the Rebbe assured, on Erev Pesach (April 16th), she was discharged from the hospital and returned home.

Two months after she returned home, in a letter dated 27 Sivan, 5733, R. Dovid wrote to the Rebbe:

"[The condition of] my daughter Chaya Mushka, may she be well, thank G-d, is improving day-to-day. On the third of Tammuz, they will perform an X-ray on her leg in order to know whether she will be able

to walk straight. We don't know vet whether she'll be able attend to summer camp for the first trip, though I expect that she will attend for the second, or at least for the third."

She always referred to herself as the Rebbe's child, and in that vein, was truly his devoted chossid, and an exemplar of emunah and bitachon in Hashem - a trait which she imparted to her family and the many women she affected as an active member of N'shei Chabad in Philadelphia. On the 14th of Teves, 5764 (January 8, 2004), at the age of 44, after a lengthy illness, she returned her pure soul to her Maker.
